Thomas C. Hebrank ("Receiver"), the Court-appointed permanent receiver for 1 2 Copeland Wealth Management, a Financial Advisory Corporation ("CWM"), Copeland Wealth Management, a Real Estate Corporation ("Copeland Realty"), and 3 their subsidiaries and affiliates (collectively, the "Receivership Entities"), hereby 4 5 submits his ninth interim application for approval and payment of fees and reimbursement of expenses. This application covers fees and costs incurred during the period October 1, 2013 through December 31, 2013 (the "Application Period"). 7 The Receiver has incurred \$18,411.75 in fees and \$956.29 in costs for this 8 Application Period. Detailed descriptions of the services rendered are contained in 9 Exhibit A attached hereto. Exhibit B is a chart reflecting the hours and fees billed to 10 11 each category of services on a monthly basis during the Application Period. 12 Exhibit C is a summary of the out-of-pocket costs. During the Application Period, 13 the Receiver and his staff have spent 95.9 hours at an overall blended billing rate of \$191.99 per hour. The Receiver has discounted all fees by ten percent (10%) from 14 regular hourly billing rates. The Receiver is requesting and seeking interim 15 16 approval and payment of 75% of the fees for the Application Period totaling \$13,808.81, and costs totaling \$956.29. The 75% interim award amount is 17 consistent with the Court's ruling on the Receiver's Second, Third, Fourth, Fifth, 18 Sixth, Seventh and Eight Interim Fee Applications. 19 20 21 I. OVERVIEW A detailed description of the history and status of the case is contained in the 22 Receiver's Report #7 and subsequent filings. The following is an overview of the 23 Receivership case for the Application Period. 24

A. Copeland Realty Business Operations

The Receiver has now settled and abandoned his interest in the Real Estate Limited Partnerships, either to the remaining limited partners or to the lender, with

approval from the Court. The activity relating to the Real Estate Limited Partnerships during this Application Period was as follows:

1. Copeland Properties Eighteen ("CP18") – The Court approved a sale of the property which closed on December 7, 2012 for \$8,550,000.00. The sale was complicated by the lender on the property, as well as various other parties who also claimed an interest in the CP18 sales proceeds. A settlement was negotiated with the lender, and approved by the Court on September 30, 2013. Various motions were filed and pending with the Court for resolution of the claims by the other parties in this matter. Extensive time was spent in responding to these claims and the various related appeals. After numerous claims and appeals by Tri Tool, the Court on January 9, 2014, denied Tri-Tool's final appeal. The Receiver made the final distributions to the CP18 partners and other parties shortly thereafter, as previously approved by the Court.

B. Notes Receivable Recoveries

In conjunction with General Counsel, the Receiver has made demand for payment, has collected some obligations in full, and in other cases has negotiated settlements with account debtors to collect on notes receivables owed to various Receivership entities. During this Application Period, the Receiver coordinated with General Counsel to finalize the short sale related to the real property located at 42695 Death Valley Road, Banning, CA 92220 ("Nizzia Property"), resulting in a total recovery of \$129,285.32 to the Receivership Estate.

To date, the total amount of \$767,270.31 has been collected, detailed as follows:

- 1. The Receiver has collected \$66,000.00 from Myra and Gordon Peterson;
- 2. The Receiver has collected \$17,907.90 from James Watson;
- 3. The Receiver has collected \$355,000.00 from SoCal Del;
- 4. The Receiver has collected \$117,844.78 from Gina and Scott Spraggins;

- 5. The Receiver has collected \$70,732.31 from Dr. Vellore Muraligopal and the Muraligopal Living Trust;
 - 6. The Receiver has collected \$6,000.00 from Bobby Bhasker-Rao;
 - 7. The Receiver has collected \$4,500.00 from Venkatasvara Rao; and
 - 8. The Receiver has collected \$129,285.32 from the short sale of the Nizzia Property.

As explained above, several of the settlements negotiated involve installment payments, at least one of which extends out as far as two years. In addition, Receiver's General Counsel is continuing to pursue additional settlements and various other remedies on some of the remaining notes receivables outstanding.

C. <u>Proof of Claims and Planned Distributions</u>

During the Application Period, the Receiver prepared distribution schedules and filed motions with the Court addressing distributions planned for the Copeland Fixed Income and Copeland Wealth Management entities. The Court approved these motions on January 2, 2014. Concurrent with this Fee Application, the Receiver is proposing distributions for Copeland Fixed Income Two, L.P. and Copeland Fixed Income Three, L.P. Sufficient funds do not exist for a distribution for Copeland Fixed Income One, L.P., and any future distributions for Copeland Wealth Management cannot yet to be determined due to outstanding claims and expenses.

D. Wrap-up of the Receivership

The Receiver has been working with General Counsel to wrap-up the receivership and proposes turning over the remaining tasks to a liquidating trustee, with approval by the Court. The Receiver has identified potential third party liquidating trustees or agents that he intends to recommend to the Court to be appointed to oversee any remaining collections and distributions, to oversee final

administrative matters such as tax returns, and to address any unforeseen additional matters that may arise after the Receiver is discharged.

The Receiver originally proposed ending the receivership prior to year-end, and then in February 2014. However, with the delays relating to Tri Tool and the CP18 appeals (which also affects other proposed final distributions), the wrap-up of the receivership has been further delayed. Tri Tool filed an additional appeal on February 13, 2014.

II. FEE APPLICATION

The Receiver has recorded its time in the following categories:

- A. General Receivership
- B. Asset Investigation & Recovery
- C. Reporting
- D. Operations & Asset Sales
- E. Claims & Distributions
- F. Legal Matters & Pending Litigation

Although some tasks cross multiple categories, effort is made to allocate time to the most appropriate category in each instance.

A. General Receivership

This category contains time spent by the Receiver on (a) participating in meetings and conferences with the SEC and legal counsel, (b) general administrative matters including reviewing mail, emails and other correspondence directed to the Receivership Entities, (c) correspondence and communications with lenders, vendors, and tenants, (d) general bank account administration, (e) maintaining and updating the Receiver's website with case information and documents, (f) the employment of professionals, (g) traveling to Court hearings, investor

communications and conducting an investor general meeting, and (h) administrative time involving the issuance of reports and sending of investor correspondence.

The Receiver requests that the Court approve \$956.29 in costs. A detailed listing of each expense is summarized in Exhibit C. The Receiver charges \$.15 per page for copies and all other items are billed at actual cost. Any travel reflects coach airfare and reasonable accommodations billed at cost.

III. THE REQUESTED FEES ARE REASONABLE AND SHOULD BE ALLOWED

A. Efficient Staffing – Customary Rates

The Receiver believes his request is fair and reasonable and that the fees and costs incurred were necessary to the administration of the receivership estate. The Receiver's request for compensation is based on its customary billing rates charged in similar matters, discounted by ten percent (10%). The blended hourly rate for all services provided by the Receiver during the Application Period is \$191.99. The Receiver's billing rates are comparable or less than those charged in the community on similarly complex matters. Although the Receiver reviews his hourly rates and adjusts them annually on January 1 to reflect greater experience and expertise, additional costs of operation, and comparable rates in the marketplace for

1	competitive receivership firms, no rate adjustment will be requested in this case for
2	2014.

4	B. <u>Costs</u>
5	The Receiver also requests Court approval of \$956.29 in costs. A summary of
6	costs is included as Exhibit C. The Receiver charges \$.15 per page for copies and
