Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"), counsel for Thomas C. Hebrank ("Receiver"), Court-appointed receiver for First Financial Planning Corporation d/b/a Western Financial Planning Corporation ("Western"), and its subsidiaries and the General Partnerships listed in Schedule 1 to the Preliminary Injunction Order entered on March 13, 2013 (collectively, "Receivership Entities"), hereby submits this Thirty-Fourth Interim Application for payment of professional fees and reimbursement of costs for the time period October 1, 2020 through December 31, 2020 ("Thirty-Fourth Application Period"). Allen Matkins incurred \$10,129.05 in fees and \$9.12 in costs during the threemonth period and seeks interim approval and payment of 80% of fees incurred, or \$8,103.24, and 100% of costs incurred. As it has throughout the case, Allen Matkins has discounted its customary hourly rates by 10%.

### I. FEE APPLICATION SUMMARY

During the Thirty-Fourth Application Period, Allen Matkins provided a total of 20.70 hours of service for a total of \$10,129.05 in fees. Allen Matkins requests payment on an interim basis of 80% of this amount, or \$8,103.24. The firm has provided its services in the following categories, as discussed in further detail below and as set forth task-by-task in Exhibit A:

#### II. TASKS PERFORMED

During the Thirty-Fourth Application Period, Allen Matkins worked diligently to assist the Receiver with legal issues affecting the receivership. The

following is a discussion of Allen Matkins' work, broken down by the categories listed above.

### A. Reporting

This category includes time spent preparing the Receiver's Thirty-Third Interim Report filed on November 28, 2020. Dkt. No. 1789. The report includes detailed updates regarding closed and pending sales of properties, and receipts and disbursements for the receivership estate. The reasonable and necessary fees for work in this category total \$1,345.50.

# **B.** Operations and Asset Sales

Allen Matkins' time in this category focused on sales of receivership properties via the Modified Orderly Sale Process. During the Thirty-Fourth Application Period, this work focused on the Washoe III, the two-acre portion of the Minden property, and the Western-owned Dayton property. The reasonable and necessary fees for Allen Matkins' work in this category total \$7,800.30.

# **C.** Claims and Distributions

Allen Matkins assisted in responding to direct inquiries from investors or their counsel regarding distributions. The reasonable and necessary fees for this work total \$362.25.

# D. <u>Employment/Fees</u>

Although fee applications are a necessary component of federal equity receiverships, neither the Receiver nor his professionals bill time for preparing their own detailed applications. Allen Matkins assisted the Receiver in preparing his Thirty-Second and Thirty-Third Fee Applications. The reasonable and necessary fees for this work total \$621.00.

# E. <u>Summary of Costs Requested</u>

Allen Matkins requests the Court approve reimbursement of \$9.12 for out-of-pocket costs incurred in executing the foregoing tasks, as itemized in Exhibit A. Pursuant to the Court's Order Granting in Part First Fee Applications, Allen

Matkins has reduced its request for reimbursement of copy costs to five cents per page and written off any excess copy charges incurred.

#### III. FEES AND COSTS INCURRED AND PAID TO DATE

From inception of the receivership through December 31, 2020, the Receiver incurred fees and costs of \$2,485,224.19, of which amount \$487,976.31 is subject to holdback pending approval of the Receiver's final fee application at the conclusion of the receivership, \$9,767.29 awaiting the Court's review and approval, and \$1,989,419.19 has been approved by the Court and paid to date. During the same time period, Allen Matkins has incurred fees and costs of \$1,871,455.65, of which amount \$382,332.00 is subject to holdback pending approval of the Allen Matkins' final fee application at the conclusion of the receivership, \$10,138.17 is awaiting the Court's review and approval, and \$1,481,011.29 been approved by the Court and paid to date. Finally, during the same time period, tax accountant Duffy Kruspodin & Company, LLP ("Duffy") has incurred fees and costs totaling \$972,104.93, all of which has been paid to date for preparing tax returns for Western, GP, and other non-GP Receivership Entities.

# IV. APPROVAL OF REQUESTED FEES AND COSTS

In its Order Granting in Part First Interim Fee Applications ("First Fee Order"), the Court analyzed the case law regarding approval of interim fee applications in regulatory receiverships and determined the following factors should be considered: (1) the complexity of the receiver's tasks; (2) the fair value of the time, labor, and skill measured by conservative business standards; (3) the quality of work performed, including the results obtained and the benefit to the receivership estate; (4) the burden the receivership estate may safely be able to bear; and (5) the Commission's opposition or acquiescence. Dkt. No. 169, p. 7.

# A. Complexity of Tasks

Here, the tasks performed by Allen Matkins are significantly complex and the number of hours billed to complete them are reasonable. These tasks include

(a) advising the Receiver regarding federal equity receivership, debtor/creditor rights, real property, contract, insurance, tax, civil procedure, judgment enforcement and other applicable areas of law, and (b) assisting the Receiver in selling assets, (c) assisting the Receiver in distributing receivership assets in a manner that treats investors fairly and equitably, and (d) providing detailed reports to the Court and interested parties.

# B. Fair Value of Time, Labor & Skill

The Court has previously determined on multiple occasions that the discounted hourly rates of Allen Matkins represent the fair value of their time, labor, and skill. Accordingly, Allen Matkins' discounted hourly rates continue to represent the fair value of its time, labor, and skill. In addition, Allen Matkins wrote off and did not charge for 1.70 hours of time during the Thirty-Fourth Application Period (\$879.75).

#### C. Quality of Work Performed

Allen Matkins has diligently and competently assisted the Receiver in all aspects of the receivership, including preserving and protecting the assets of the Receivership Entities, analyzing the Receivership Entities' assets and liabilities, addressing Western's cash shortage, reducing Western's operating expenses as well as administrative expenses of the receivership, selling assets and collecting loans, protecting the Receivership Entities' interests in pending litigation and other legal matters, preserving and pursuing causes of action against third parties, formulating plans and procedures for the determination of investor claims and the fair and equitable distribution of receivership estate assets, and preparing detailed reports to the Court and interested parties. These services have allowed the Receiver to preserve and protect the value of the Receivership Entities' assets for the benefit of investors.

# D. <u>Receivership Estate's Ability to Bear Burden of Fees</u>

Pursuant to the Court's May 25, 2016 Order (Dkt. No. 1304), the assets of the Receivership Entities (Western and the GPs) have been pooled, creating a common pool of receivership estate cash from which mortgages, property taxes, and other operating expenses have been and will continue to be paid. The cash balance has grown and will continue to grow as properties are sold through the Court-approved Modified Orderly Sale Process (Dkt. Nos. 1309, 1359). As a result of sales closed as of December 31, 2020, and factoring in interim distributions that had been cashed as of that date, the receivership estate held approximately \$4.08 million. Dkt. 1799. Therefore, the receivership estate has the ability to pay the fees and costs requested herein.

# E. Commission's Opposition or Acquiescence

Prior to filing, the Receiver and Allen Matkins provided these fee applications to counsel for the Commission in substantially final form. Counsel for the Commission has advised that the Commission has no opposition to the fees and costs requested.

Accordingly, the five factors identified by the Court for considering interim fee applications all support interim approval and payment of the requested fees and costs.

#### V. CONCLUSION

WHEREFORE, the Receiver and Allen Matkins respectfully request entry of an order:

1. Approving payment of fees to Allen Matkins on an interim basis of \$8,103.24;

Approving reimbursement of expenses to Allen Matkins on an interim basis of \$9.12;

2. Authorizing and directing the Receiver to pay these amounts to Allen Matkins from assets of the Receivership Entities; and
